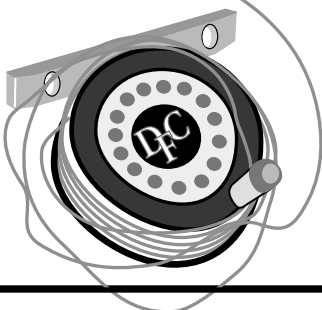

September is Swap Meet Month

September 11th is the annual swap meet for DFC members. If you have some equipment that you no longer use and would like to sell bring it to the September meeting and put a price on it. This is also a good opportunity to shop for any equipment that you need, but don't want to pay "new" price for. Come on out and buy, sell, or trade equipment with your fellow DFC members and socialize a little. This is a great meeting for all the members that like to talk during the presentations because we don't have a speaker this month and you can talk all you want to during the meeting and no one will give you dirty looks or ask you to be quiet (: Dinner will be served from 6pm until 7pm. For any of you who are interested in salt water fly fishing, I hear that there will be some top end rods available at this years swap meet. We will also be trying out our brand new sound system. Hope to see everyone there.

these items were Commission Order 40 issues and one of the items was a native Trout issue that I think is closely related to the other issues. The other thing is some updated information on Canyon Creek.

For those of you who don't know what a Commission Order 40 issue is (like me until someone told me). It is a rule or law change that is proposed by G&F to the Arizona Game and Fish Department Commission. If the Commissioners agree with G&F the changes are enacted and laws are changed.

The first Commission Order 40 issue that was discussed concerned rule changes at Lees Ferry. The changes that are proposed are to change the daily bag limit from 2 trout to 4 trout and the possession limit from 4 trout to 8 trout. Change the law from reading that trout over 16 inches cannot be possessed to reading that trout over 12 inches cannot be possessed. All trout must be killed immediately or released immediately. These rule changes would be in effect from Glen Canyon Dam to the upstream end of the Paria riffle. The other proposed rule change is to take the special regulations off from the upstream end of the Paria riffle down to Marble Canyon Bridge and allow this area to be bait fishing, catch and keep area so that the locals will have some place where they can fish with conventional tackle and keep some fish for consumptive use.

The rationale for these changes is that there are too many fish for the amount of food available at Lees Ferry. If there weren't as many fish competing for the available food, the trout in the river would have a better opportunity to grow to trophy size.

There was general agreement that these rule changes would be a step in the right direction. The point was also made by the anglers in the group that we felt the way the flows in the river are managed (that effect the food mass in the river) will be the biggest determining factor on the trout population at Lees Ferry in the future.

The next Commission Order 40 issue that was discussed was to close to fishing the West Fork of the Black River from the uppermost fish barrier downstream, approximately 1.5 miles, to the confluence with Stinky Creek. This issue was met with a lot of skepticism from the five fly fishers that were present. The reason G&F want to do this is that they keep finding Brown trout above the fish barriers on the West Fork of the Black. Almost all of the Browns are found between the two barriers, with very few found above the upstream barrier. In order to get the Apache trout delisted from the Endangered Species List, G&F must show that the population of Apaches is self sustaining, free from hybridization with non native species and not in danger of predation from non native species. Game and Fish thinks that the Browns that keep showing up on the upstream side of the fish barriers are being put there by people. Their rationale is that it would be more difficult to get a live Brown trout from a mile and a half down stream and transport it up above the fish barriers than it would to stand down below the barrier, catch a few browns and throw them back over the barrier. The concerns that all the fly fishers expressed about this proposed rule change were that laws only apply to people who obey them and that it is already against the law to move Browns from below the fish bar-

UPDATE ON ARIZONA ANGLERS ROUND TABLE

Chinda Howard and I attended the Arizona Anglers Round Table on August 12th. The meeting was held at the Arizona Game and Fish Department Wildlife Building at the Arizona State Fairgrounds located at 19th Avenue and McDowell Road in Phoenix. These meetings are a new concept and will take the place of the old fish focus meetings. The meetings will be held quarterly and the location will be moved around the Valley so that it will be convenient for everyone to attend some of the meetings no matter where you live in the Valley. 16 anglers and 10 AGFD employees attended the August 12th meeting. At the end of the meeting, the agenda for the next meeting is determined by suggesting topics to be discussed and voting on which topics to put on the agenda by a show of hands. Topics are selected until they have enough to fill the three-hour time frame allotted for the meeting. If you have a concern or some topic that you would like to get more information on, this is a good way to make your concerns known or to get some discussion on a fisheries issue that you would like to have more information about.

Several topics were discussed at the August 12th meeting and I am going to pass on some information on four subjects that I thought were the most pertinent to our membership. Two of

Here are two popular and simple patterns for the San Juan.

San Juan Patterns-

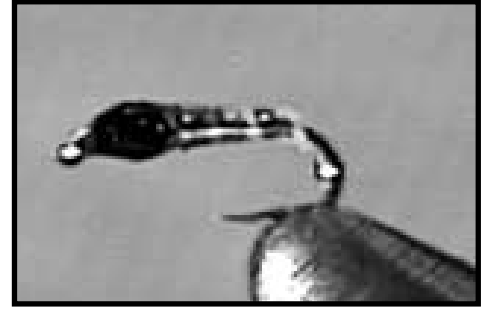
Disco Midge:

INGREDIENTS

Hook: Curved Nymph Hook in sizes 20-22
Thread: Black 8/0
Body: 1/16th Pearl Flashabou or Krystal Flash
Thorax: Black Thread

INSTRUCTIONS

1. Secure thread at head and tie in the Flashabou along the top of the hook.
2. Wrap over the Flashabou to just before bend.
3. Advance the thread forward and build a slightly tapered body, leaving the thread hanging near the head.
4. Wrap the Flashabou over the body, completely covering the thread. With the 1/16" width Flashabou this should only take 3-4 wraps.
5. Secure the Flashabou at the head with 2 or 3 tight wraps and trim.
6. Build a thorax with thread.
7. Whip finish, trim the thread and seal with a drop of super glue over the entire body of the fly. You can use a toothpick or needle to spread the drop of glue evenly. [end]



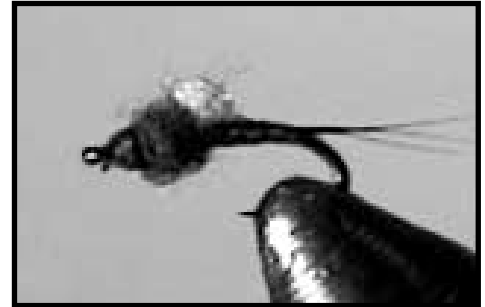
Brown Foam Wing:

INGREDIENTS

Hook: Curved Nymph Hook in sizes 20-22
Thread: Brown 6/0
Thorax: Fine Chocolate Brown Dubbing
Abdomen: Brown Thread
Wing: White Foam Post [Can use Poly fibers instead]
Tail: Split Dark Dun Microfibetts
Optional Ribbing: Twisted Black 3/0 thread
Variations: Gray, Olive or Black colors

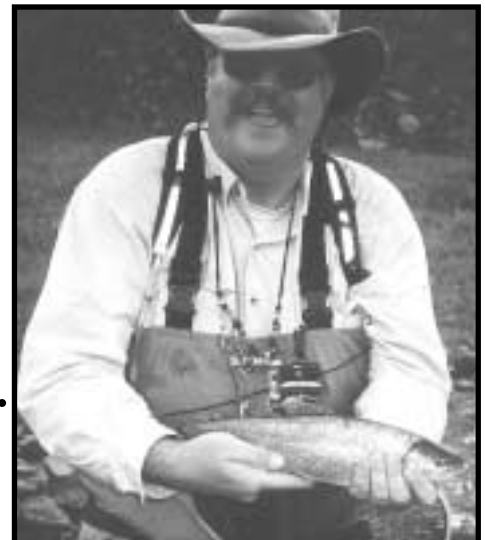
INSTRUCTIONS

1. Secure the thread at the head and wrap back to just before the bend.
2. Tie in several stripped brown hackle fibers for a tail but don't trim. Tail should be as long as the body.
3. Wrap the thread forward over the hackle and build a tapered thread body. Make sure to stop with plenty of room to build a thorax. Trim any remaining hackle butts.
4. Tie in the foam wing toward the front with several tight turns. The post should point toward the bend. Trim the tag end of the foam.
5. Dub the thorax with chocolate brown dubbing. Make sure and take one or two turns under the foam wing to force it slightly up before finishing the thorax.
6. Form a nice thread head.
7. Whip finish, add head cement, and trim foam wing to about 1/16 inch. [end]

riers to above the fish barriers. I told the G&F personnel that the only time I had ever seen a Game and Fish employee on the West Fork of the Black River was on a work outing. Any one who would throw Brown trout from below the fish barrier upstream would probably realize that there would be very little chance of getting caught in the act because there are hardly ever any game wardens present on the West Fork. I feel that this rule change, unless changes are made in enforcement efforts, would have the effect of creating 1.5 miles of private fishing for unethical anglers and would not have any effect on the problems with Brown trout above the fish barriers. I don't think we need more laws. If the laws that are already in place were being enforced, they would take care of the problem.

Along this same line of Native Trout issues, the reintroduction efforts of the Gila trout were briefly discussed. G&F said that all is going well with the reintroduction efforts of the Gila Trout, and that efforts are being pursued to get them downlisted and make limited sport fishing opportunities available to anglers. Then they said that as far as they can determine that there has been no reproduction in Dude Creek or Raspberry Creek. This seems like some kind of oxymoron to me.

The last issue that we discussed was the damage done to Canyon Creek by the Rodeo-Chediski fire. Mr. Jim Warnecke, biologist from region 6, had some pictures and a couple of very informative reports that he shared with the group. The bad news is that the after effects of the fire killed all the trout in the creek, as best as can be determined. The pools in the stream are full of mud and ash from the heavy rains in the area that we had right after the fire. The good news is that the flood did not destroy the streambed. Mr. Warnecke feels that if we have good snow pack and runoff next spring, that Canyon Creek may clean up to where it would be a good place for trout to live again next year. I think the restoration and repair work that will be necessary would be a great project for DFC to get involved in. Lets all hope for lots of snow this winter.

PLAYING THE TIDE GAME

"Oh @#\$\$%^" or some sort of harsh bowling language blared from the man running through the azure saltwater. Vince's very nice and very expensive float tube with camera, lunch and spare, hard to find reel had drifted off of our sand bar.

While enjoying the male bonding of a festive DFC meeting, I asked Vince Deadmond if he would like to hook up for a trip to Puerto Penasco (Rocky Point for you Gringos). Faster than Jim Dixon can order a second Bud Heavy, Vince said "Sure".

Friday night was very pleasant; I had plenty of CD's and just set the big Dodge on cruise and sped into the falling sun. Insurance purchase at Gringo Pass and border crossing went smooth as duck hackle.

Ten o'clock found me at Vince's trailer in Playa Del Oro RV Park. He was just sitting down to a grilled steak with mushrooms. "Hey, got enough for two" I said. "NO", was the mannerly but firm response. "OK! OK!" "I get the point." I wanted a street vendor chicken taco anyway. You can have steak and mushrooms anytime. But not a Rocky Point chicken taco.

What a camper that Vince is. I thought Gordon McHardy had creature comforts. Air conditioning has it all over a solar shower. Yes, Vince has an air conditioner rigged up on his trailer. VERY COOL!

After a deep REM sleep we drove twenty miles south and on to the beach just north of the Mayan Palace Casino. The beautiful Ford F150 floated over the sand like a Pale Morning Dun on a warm morning.

Vince had timed it just right, one hour before the ebb tide would slack and the flood tide start. This is the angle for fishing tidal water, especially at Puerto Penasco and Port Lobos. The tide will float you out then float you back in. Dave Weaver has been doing this for years. So after watching him for years, I thought "Hey" I can do that. Vince rigged up first and couldn't resist chucking his Clouser into the briny. Whamo! A nice pompano on the first cast. It's gonna be good day.

Here is one of the countless reasons I like saltwater fishing, rigging up a 2/0 fly with 10# leader. None of that 8X tippet with a 22 nymph. My 6wt - 9' - Sage with Ross C-2 Cimarron reel and medium sink line is ready.

The catching starts right away; we are drifting over Cabrillos, landing one right after another. Each hook up has my outfit straining and what is it, an 8" fish. Wowsers! Can those little guys pull! As we drift in to La Pinta estuario, a sand bar was still above water. It appears we could get out of our tubes and can walk around, while casting into the surrounding channels. The panorama resembles glossy magazine ads for some far-away exotic flats destination. Not only did it look like the exotic far-away exotic flats destination, but became more so when Vince hooked and landed one, two, then a third bonefish with out moving. This was amusing since Vince had recently been to Andros Island in the Bahamas and only caught three Bones in one day. The both of us were casting to all the channels surrounding our sandbar, but "No mas' Bones. Apparently the slightest change in the tide washes them out.

Before we could jump in our tubes and float out in the channels, I hear "My float tube came untied"! Vince was making a valiant effort to swim after it; the wind was just a little too fast for Vince the Merman. Taking a segment from the movie Castaway (Vince does sort of resemble Wilson) we swim across the estuario while holding on to the side handles of my float tube.

After much tedium, we located the errant-floating device. Unfortunately, for Vince, it was across a sizable channel. My float tube was called to action again, floating Vince through the channel to his tube. After the rescue, we headed back to town for showers and happy hour.
